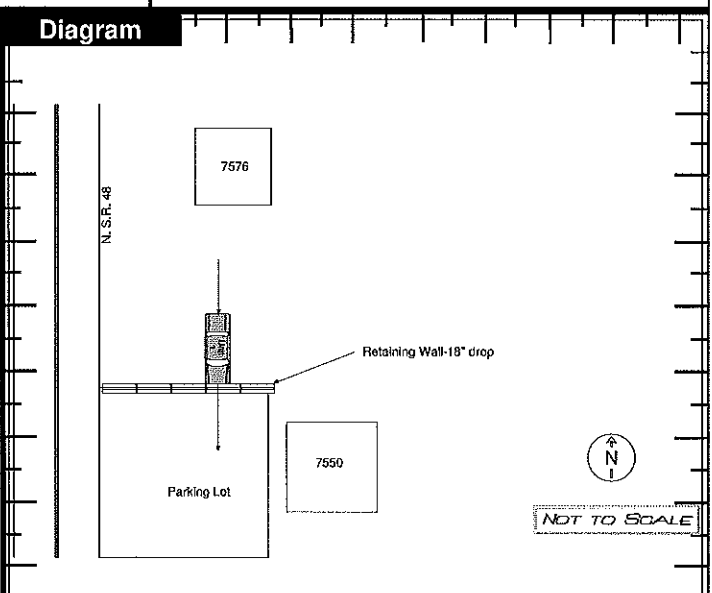



While on scene, we developed information of possible suspect, Lucian Hatfield, 607 North St., Waynesville, Oh. 45068. Mr. Hatfield had been in a verbal disagreement with the employees at Game Day Grille, 7576 N. S. R. 48, and he had left minutes before the crash.

Sgt. Cornett and Waynesville PD responded to 607 North St., Waynesville. Upon arrival, a silver 2001 Lincoln Towne Car, with Oh 855YFN, was parked in the driveway. The vehicle was observed to have apparent fresh damage to the left front corner and undercarriage, consistent with the crash. The motor was warm.

We knocked on the door for several minutes, but received no answer. We checked through the windows and located a person later identified as Lucian Hatfield seated on the floor. Mr. Hatfield stated he was unable to come to the door, but granted permission to come into his house through the garage door.

We rolled up the attached garage door and entered the residence. Upon entering we were met by Mr. Hatfield. Mr. Hatfield was observed to have a strong odor of intoxicants on or about his person which got stronger when he spoke. He was unsteady about his feet, and had slurred speech. It should be noted Mr. Hatfield had no visible injuries, and denied being injured.

Mr. Hatfield admitted to being at Game Day, and left via S. R. 48 to S. R. 73 in going home. He stated he had only had "two beers" while at Game Day. Mr. Hatfield also admitted to having driven through the grass between 7675 and 7550, but stated he didn't realize he had struck and fallen from the retaining wall.

Mr. Hatfield was cited for Stopping After Crash: Damage to Realty, as he didn't stop and attempt to contact anyone at 7550, which was an open and operating business. Due to the time between the crash, and being unable to show Mr. Hatfield's level of alcohol in his system, he was not charged with OVI.
