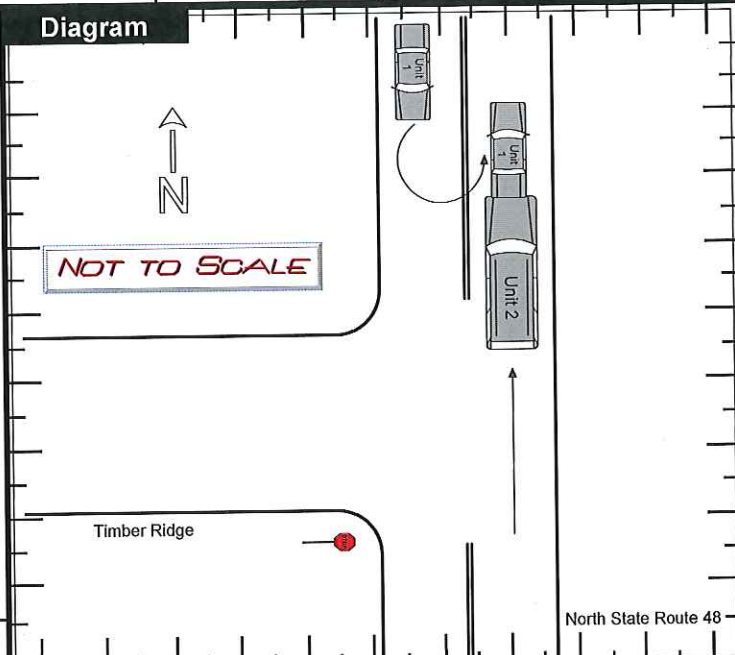

Unit 1 failed to maintain reasonable control during the inclement weather and spun around 180 degrees causing Unit 1 to be directly in front of Unit 2, facing North. Unit 2 was not able to stop in time and struck Unit 1 in the rear.
