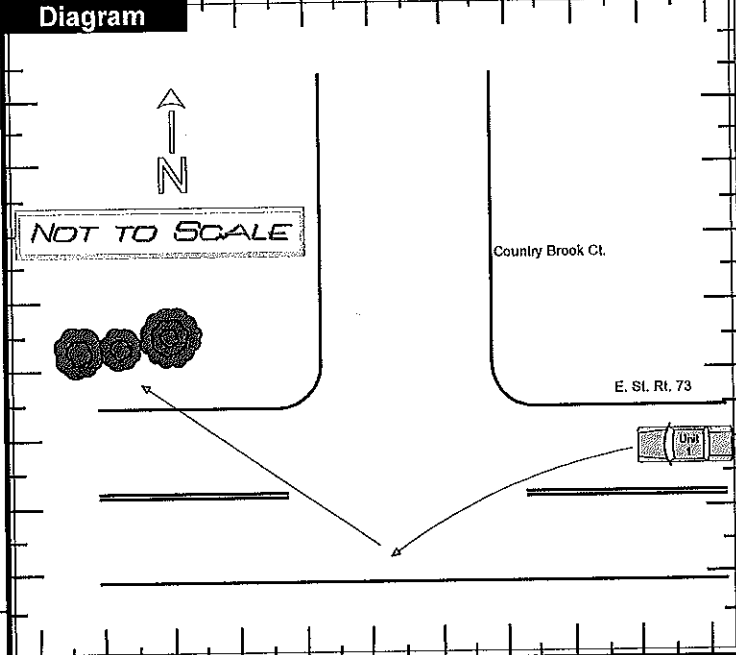

NARRATIVE
Unit 1 was traveling westbound on E. St. Rt. 73 approaching Country Brook Ct. According to the driver of unit 1, a white vehicle pulled out of Country Brook Ct. turning eastbound directly in front of him. Unit 1 then had to swerve to the left to avoid the other vehicle. Unit 1 overcorrected when trying to turn right back into the proper lane of travel and as a result ran off the roadway to the right striking trees on the side of the roadway. The white vehicle never returned to the scene.
