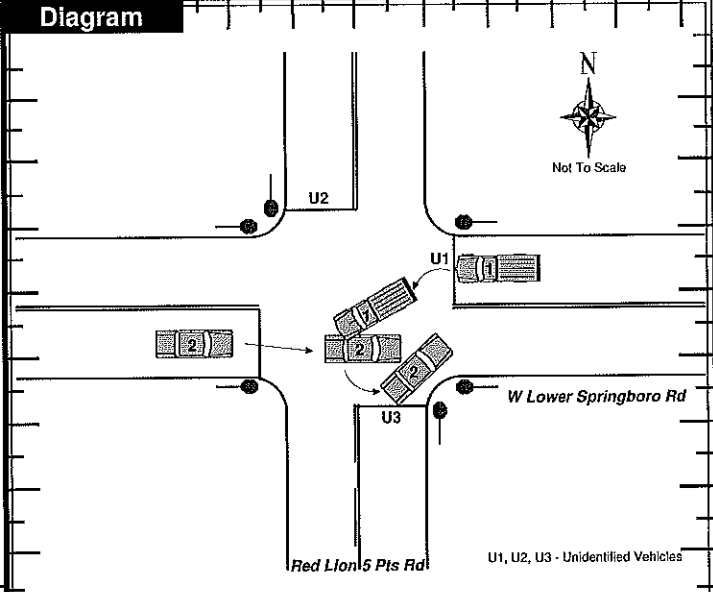

Unit 1 and Unit 2 were traveling in opposite directions on W Lower Springboro Rd and simultaneously approached the congested four way stop at the intersection of Red Lion-5 Pts Rd. There were three unidentified vehicles stopped at the intersection prior to Unit 2 coming to a complete stop at the stop bar. Two of the unidentified vehicles (U1 and U2) entered the intersection, one of which (U1) was in front of Unit 1. Unit 2 waited for the third unidentified vehicle (U3) to enter the intersection, which it did not. Unit 2 then entered the intersection attempting to continue traveling eastbound on W Lower Springboro Rd. Unit 1, who came to a stop at the stop bar after Unit 2, also entered the intersection attempting to make a left hand turn onto Red Lion-5 Pts Rd. Unit 1 failed to yield right of way to Unit 2 and struck Unit 2 to the driver rear passenger door.

Unit 2 had a dash camera mounted in the passenger compartment of the vehicle facing to the front of Unit 2. Review of the dash camera video indicates Unit 2 was in fact stopped at the stop bar as the unidentified vehicle (U1) in front of Unit 1 clears the intersection. As a result, Unit 1 was required to yield right of way to Unit 2.

Unit 1 indicated that Unit 2 flashed his headlights and he assumed Unit 2 was requesting he enter the intersection. Unit 2 indicated that he does not specifically recall flashing his headlights, however he has commonly done so in prior instances. Unit 2 further indicated if he were flashing his headlights it was to notify the driver of the third unidentified vehicle (U3) to proceed, which it hadn't. The dash camera video confirms that Unit 2 did flash his headlights on one occasion.

A copy of the dash camera video is maintained on file with the OH-1.
