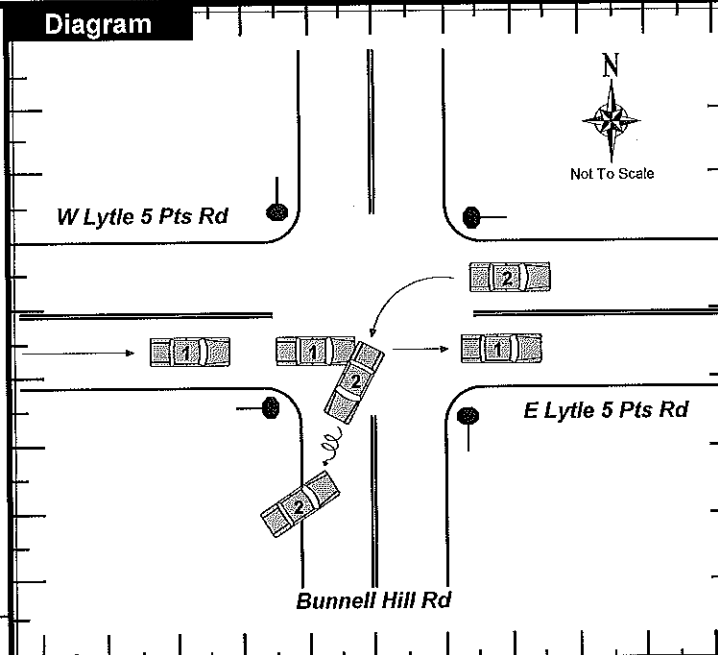

Unit 2 was traveling westbound on E Lytle 5 Pts Rd when, at the 4 way intersection of Bunnell Hill rd, Unit 2 came to a stop for the posted stop sign. Simultaneously, Unit 1 was traveling eastbound on W Lytle 5 Pts Rd. Unit 2 attempted a left turn onto Bunnell Hill Rd when Unit 1 failed to stop for the posted stop sign. As a result, Unit 1 struck Unit 2 to the rear. Unit 1 indicated she was conversating inside the vehicle and attempted to stop, but slid through the intersection.


