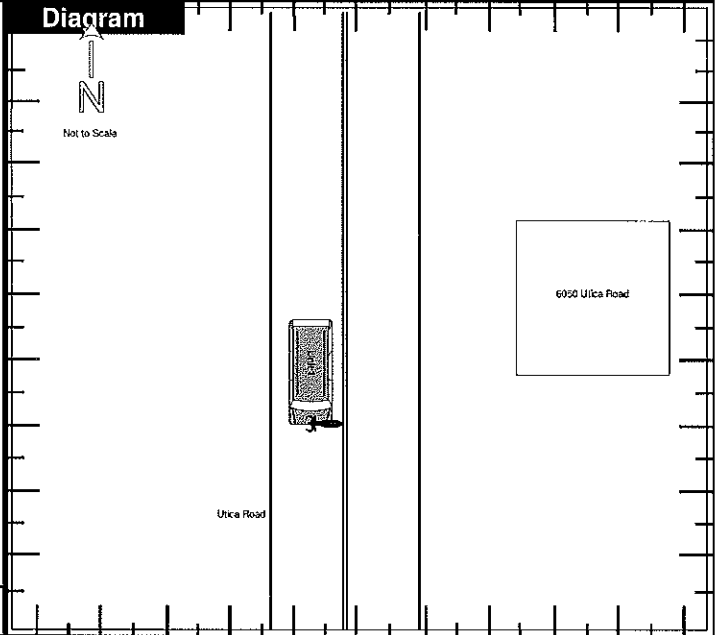

Unit #1 was traveling southbound on Utica Road and while doing so collided with a deer that darted in the roadway in front of 6050 Utica Road.




