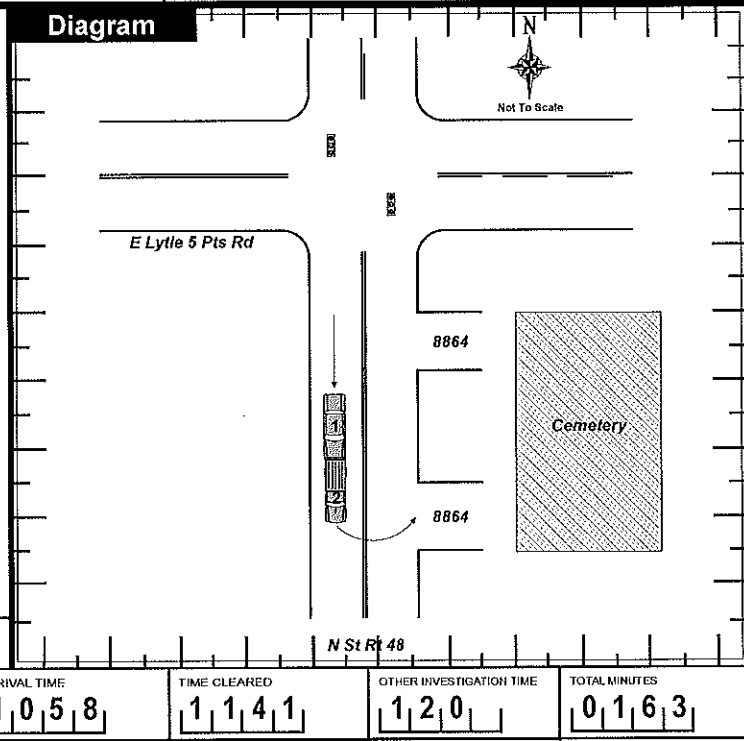

**NARRATIVE**

Unit 1 was traveling behind Unit 2 southbound on N St Rt 48 when, at the address of 8864, Unit 2 slowed to a stop to turn left into the cemetery. Unit 1 failed to assure clear distance ahead and struck Unit 2 to the rear. Unit 1 and Unit 2 exchanged insurance info at the crash scene. This agency was contacted the following day when Unit 2 learned that Unit 1 did not have current insurance coverage. This agency confirmed with Progressive Ins that Unit 1's insurance policy lapsed in May of 2017.
