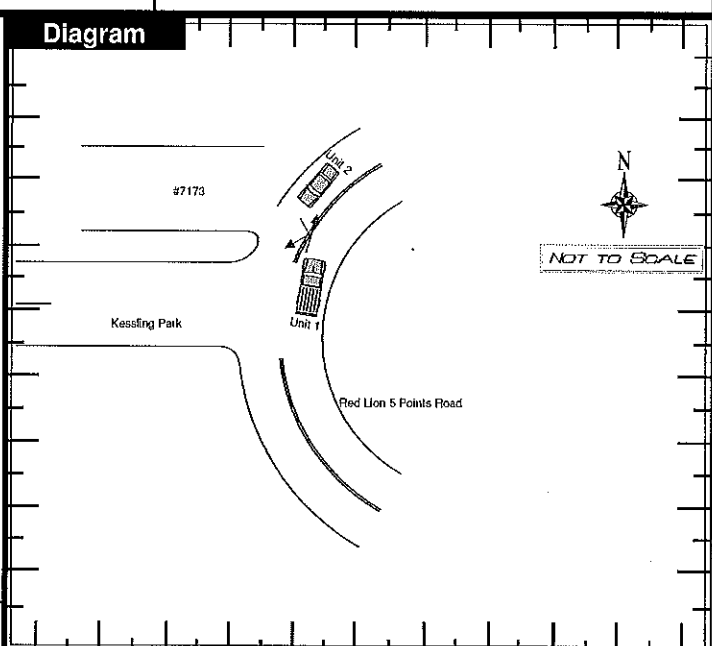

Both parties stated the other unit crossed the center line, there were no witnesses, and marks or debris in the roadway where the crash occurred so I was unable to determine who was at fault.


