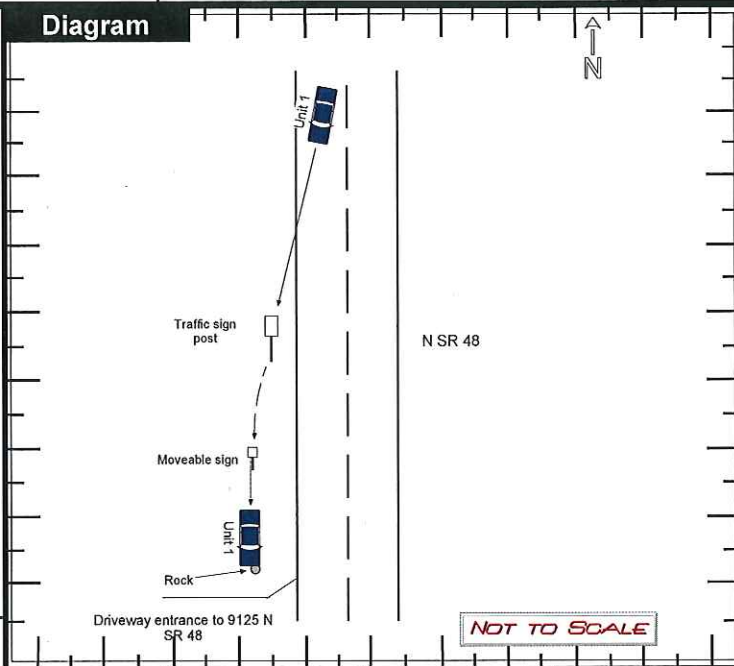

**NARRATIVE**
