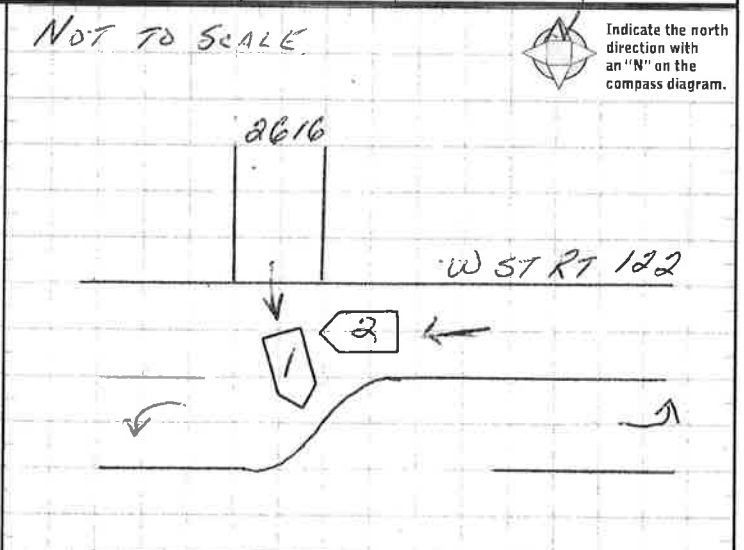

UNIT 1 WAS ATTEMPTING TO TURN LEFT FROM THE DRIVEWAY OF 2616 INTO THE EASTBOUND LANE OF W ST RT 122, WHILE UNIT 2 WAS TRAVELING WESTBOUND ON W ST RT 122. UNIT 1 FAILED TO YIELD RIGHT OF WAY AND TURNED LEFT IN FRONT OF UNIT 2. UNIT 2 WAS UNABLE TO STOP AND STRUCK UNIT 1 IN THE LEFT REAR.
