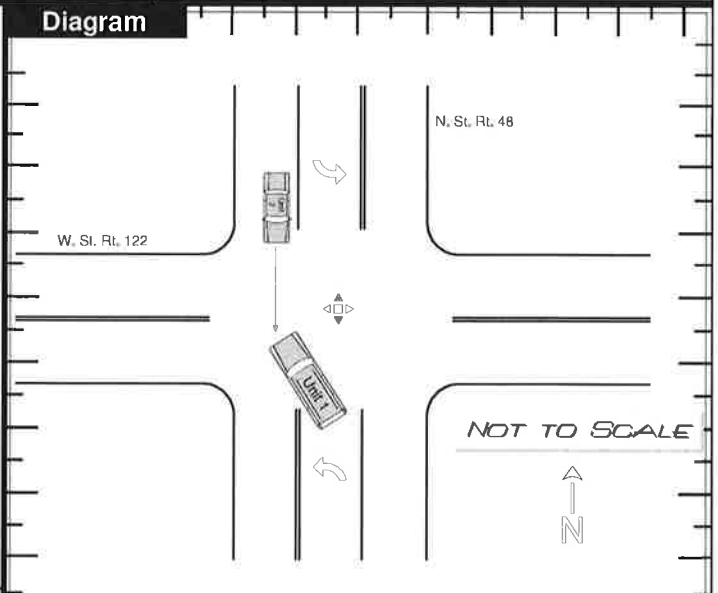

While at the intersection, unit 1 attempted to make a left turn, failing to yield to the right of way of unit 1. This caused unit 2 to strike unit 1. Multiple witnesses on scene stated that unit 2 had the green light.
