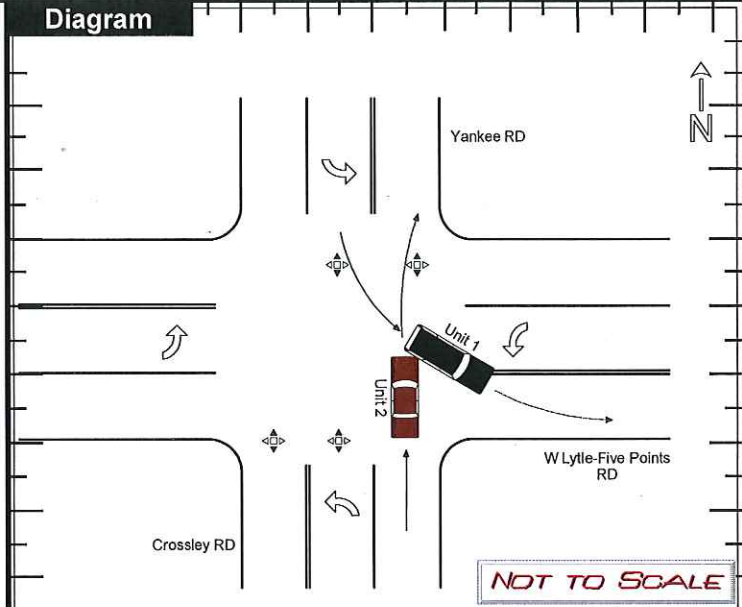

Unit Two was proceeding straight through the intersection heading north on Crossley to go onto Yankee (Crossley turns into Yankee) on a green light. Unit One failed to yield right of way to Unit Two and Unit Two struck Unit One on the right rear. The operator of Unit One stated the light was yellow for north-south traffic; the operator of Unit Two and other witnesses stated the light was green.
