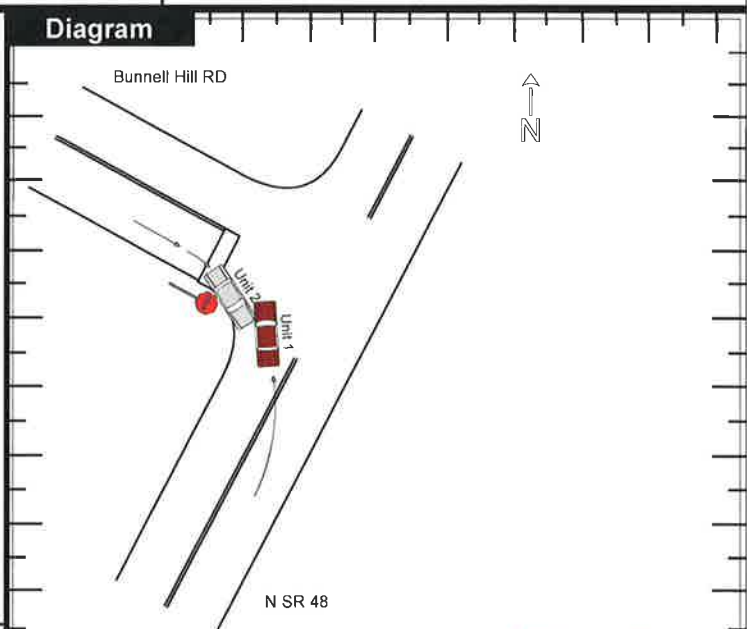

Unit One was northbound on N SR 48 approaching Bunnell Hill RD to make a left turn. On making the left turn, the operator violated rules for turns at intersections by not making the turn on the right half portion of the roadway. In doing so, Unit One struck Unit Two which was stationary just ahead of the stop bar on Bunnell Hill RD in preparation to make a right turn.

It was noted that at final rest, Unit Two's right rear wheel was on the fog line at the right edge of its proper lane of travel. Unit Two was ahead of the stop bar at final rest but its position within its lawful lane of travel indicated that it was not interfering with any vehicles making proper left turns onto Bunnell Hill RD from N SR 48. Both operators stated that neither vehicle had been moved after the crash had occurred.

The operator of Unit One stated that he did not see Unit Two prior to the crash. The operator of Unit One stated that he was talking on his cell phone at the time of the crash, which was witnessed by the operator of Unit Two.

No injuries were reported.
