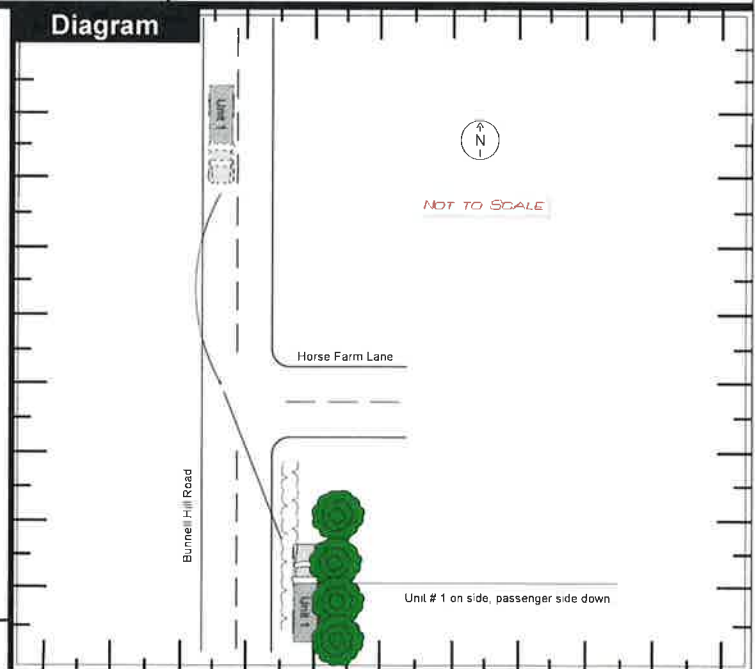

NARRATIVE

Unit # 1 was traveling South on Bunnell Hill road, near the intersection with Horse Farm Lane, when the driver stated he was having difficulty shifting and took his eyes of the road for a moment. When the driver looked back up at the road he stated he was veering into the west shoulder which caused him to steer to the left, lose control of the vehicle, cross the center line and come to final rest on the east side of the road in the ditch and tree line with his passenger side of the vehicle down.
