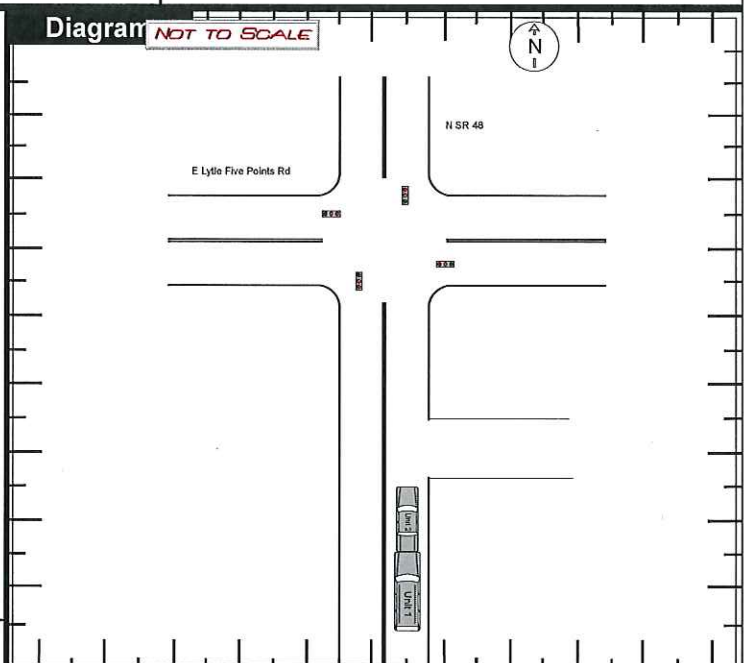

On 10/04/2017, at approximately 1801 hrs, I spoke with Diana L. Hess in the conference room of the Clearcreek Township Police Department. D. Hess stated that she had been involved in a crash on 09/22/2017, at approximately 1630 hrs. D. Hess stated that the crash had taken place at N SR 48 and Lytle Five Points Rd. D. Hess stated that she was waiting at the light when she was struck from behind by vehicle that looked similar to a Toyota RAV4.

D. Hess stated that she made contact with the other driver Elizabeth J. Lee and was provided with a phone number. D. Hess advised that E. Lee stated that she had been looking back to check on her children and had not been able to stop in time. D. Hess stated that E. Lee had advised that she did not have the insurance paperwork on her and that this was in her boyfriend's name. D. Hess advised that there were several children in the vehicle. D. Hess stated that there was some damage to the rear of her vehicle however, the other vehicle had extensive damage to the front. D. Hess stated that E. Lee advised that this was from a previous crash.

D. Hess stated that she wrote the registration down which was HAY4470. D. Hess stated that she advised E. Lee that she would have her husband look at it and contact her regarding the insurance. D. Hess advised that she got home and noticed that there was a dent in her bumper that she had not observed at the scene. D. Hess stated that she sent a picture of the dent to E. Lee with a message stating "There is a round dent on the side but I will have him take it to work and see what they say" and that she responded back "OK". This message was sent on 09/22/2017 at 1653 hrs and the reply was received on the same day at 1729 hrs.

D. Hess stated that she attempted contact with E. Lee over the next several days but could not make contact. D. Hess stated that she did finally make contact and that when she asked for the insurance information E. Lee disconnected the call.

D. Hess identified E. Lee as the driver. This photo was obtained by running the registration HAY4470 which is owned by E. Lee.

I made contact with E. Lee on 10/10/2017, at approximately 1616 hrs, and she denied that the incident had ever taken place. When pressed about how D. Hess had been able to provide her information to me E. Lee continued to deny that she even knew what I was referring to.
