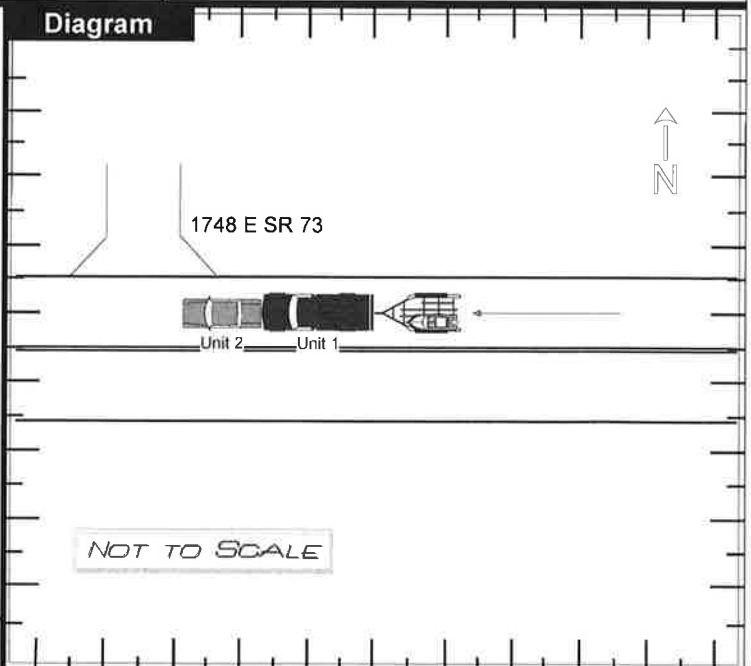

The operator of Unit Two reported experiencing back pain after the crash.
