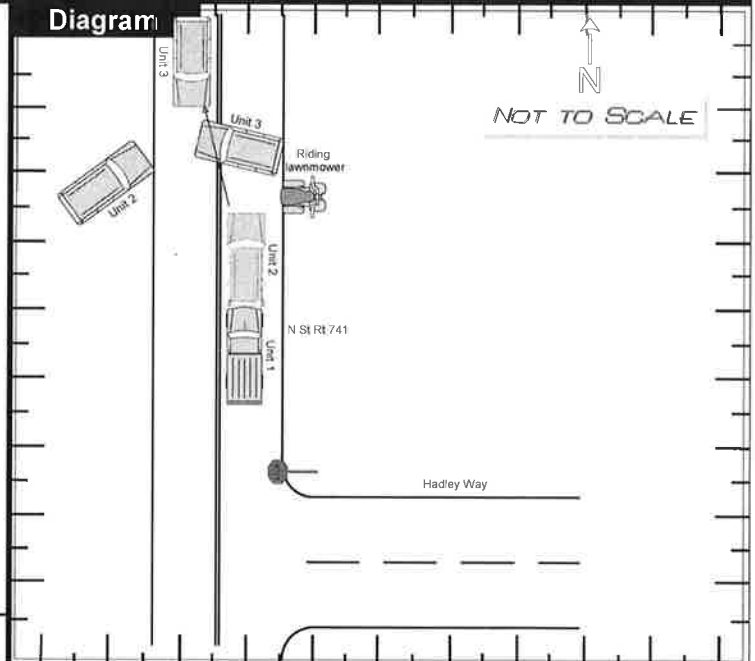

Unit 1 was traveling northbound on St. Rt. 741. Unit 2 was in front of Unit 1. Unit 3 was traveling southbound on St. Rt. 741. Unit 2 stopped to avoid hitting a riding lawn mower that was traveling southbound in his lane of travel, causing Unit 1 to strike Unit 2. Unit 2 was pushed into the southbound lane and struck Unit 3.
