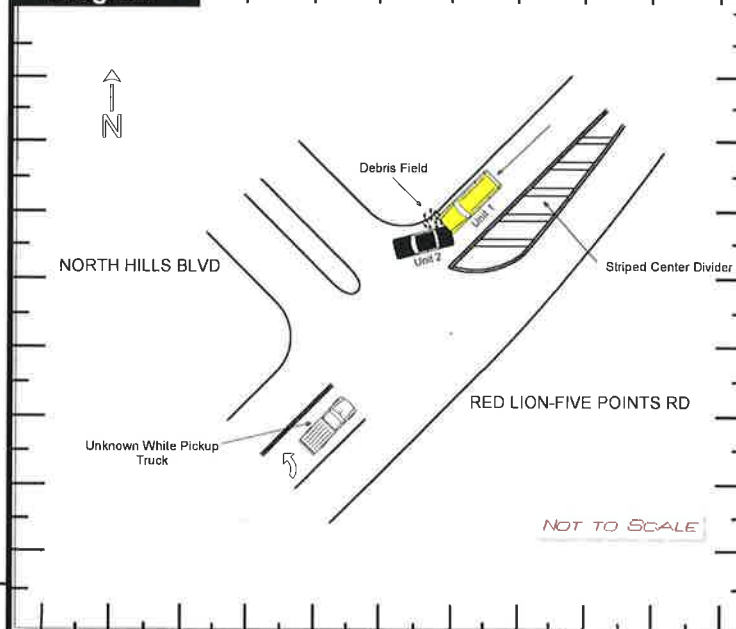

Unit Two was traveling southbound on Red Lion-Five Points Road with Unit One traveling southbound behind it. Unit Two slowed in preparation to make a right turn onto North Hills Boulevard. Unit One struck the right rear end of Unit Two as it was either stationary or traveling slowly to make its right turn, causing damage to both units. No injuries were reported. Conflicting statements were given from the two operators and an uninvolved independent witness.

The witness reported that she observed Unit Two stop abruptly as if it was about to miss its turn onto North Hills Boulevard. Unit One came to a successful, safe stop behind Unit Two at that time. Unit Two then proceeded but "slammed on its brakes" for an unknown reason, coming to another stop. Unit One, which had also proceeded to travel again, then struck the rear end of Unit Two. The witness stated that there was a white pickup truck in the left turn lane waiting to turn from Red Lion-Five Points Road on North Hills Boulevard. She reported that this vehicle did not initiate its turn or interfere with Unit Two's right of way in any way. She indicated that she had not observed Unit One operating outside of its proper lane of travel.

The operator of Unit Two reported that Unit One came up behind him quickly while traveling southbound on Red Lion-Five Points Road and attempted to pass him utilizing the yellow striped center divider portion of the roadway (not intended for regular traffic). He stated that the operator of Unit One then apparently observed that its path of travel would cause it strike a white pickup truck that was northbound waiting to make a left turn from Red Lion-Five Points Road onto North Hills Boulevard. He reported that he slowed abruptly because of the developing situation with Unit One operating in the manner it was. He stated that he believed he slowed so much that the white pickup truck then proceeded to make its left turn, possibly believing that a crash had occurred with the two vehicles. This left turn by the white pickup truck was in now conflict with his right turn onto North Hills Boulevard. He advised that he then was forced to slow down again because of the development with the white pickup truck and that is when Unit One struck his vehicle.

The operator of Unit One stated that he was operating at a speed approximately 5 over the limit on Red Lion-Five Points when he came upon Unit Two. He reported that Unit Two slowed heavily in preparation to make its turn, at which time he nearly struck it. He stated that Unit Two then proceeded but came to an abrupt complete stop at which time he struck it in the rear. He indicated that Unit Two had right of way that was not being interfered with. He stated that there was a red pickup truck in the oncoming left turn lane but it was not proceeding with its turn. He indicated that he believed "it was as if the black Infiniti (Unit Two) wanted me to hit him." He denied having utilized the center divider lane for travel.

The white pickup truck left the scene without leaving contact information. Three written witness statements were collected.

The operator of Unit One is 16 years old and had two non-family member occupants in the vehicle at the time of the crash. As no parent or guardian was on board, he was cited for the probationary license restriction (ORC 4507.071B4) in addition to ACDA. One of the occupants legally operated the vehicle from the scene with the consent of each juvenile's parent.
