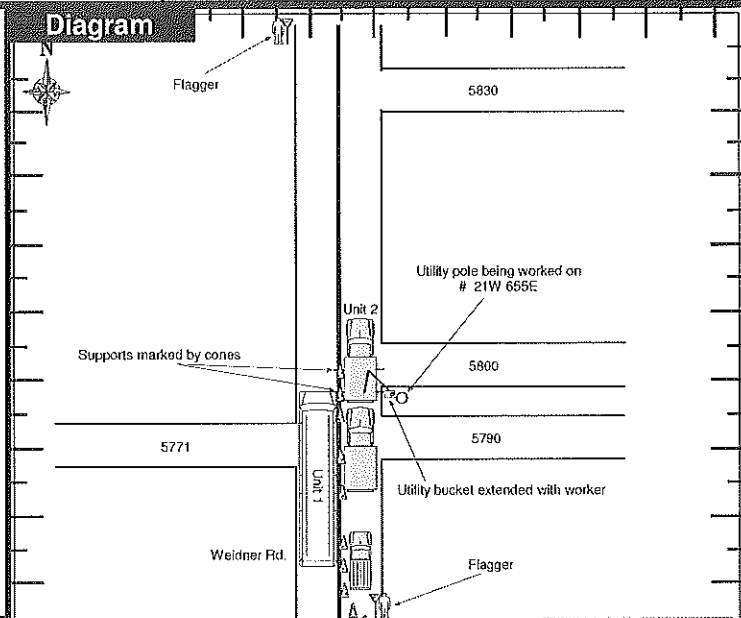

NARRATIVE
Unit 1, a school bus, was traveling northbound on Weidner Rd. when it entered a construction zone involving power utility trucks, cones, and flaggers with the northbound lane closed. Unit 01 went northbound in the southbound lane, following the flaggers orders, and struck a support for the utility truck (Unit 2) that was marked with a cone but was over the centerline. There were 26 students and a driver on the bus and a worker extended in the bucket of the truck.
