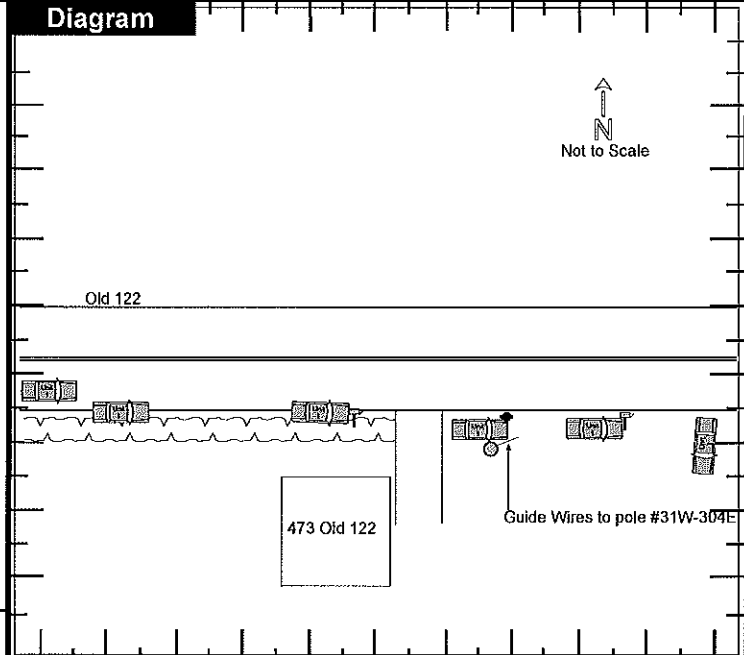

**NARRATIVE**  
Unit #1 was traveling eastbound on Old 122 and in doing so failed to maintain reasonable control of his vehicle, traveling off the right side of the roadway. Unit #1 traveled in ditch and collided with a mailbox in front of 473 Old 122. He continued off the roadway colliding with a fire hydrant and guy-wires to pole #31W-304E. He then collided with a mailbox in front of 495 Old 122. The collision caused the fire hydrant to be torn from its base and the pole to be broken.
