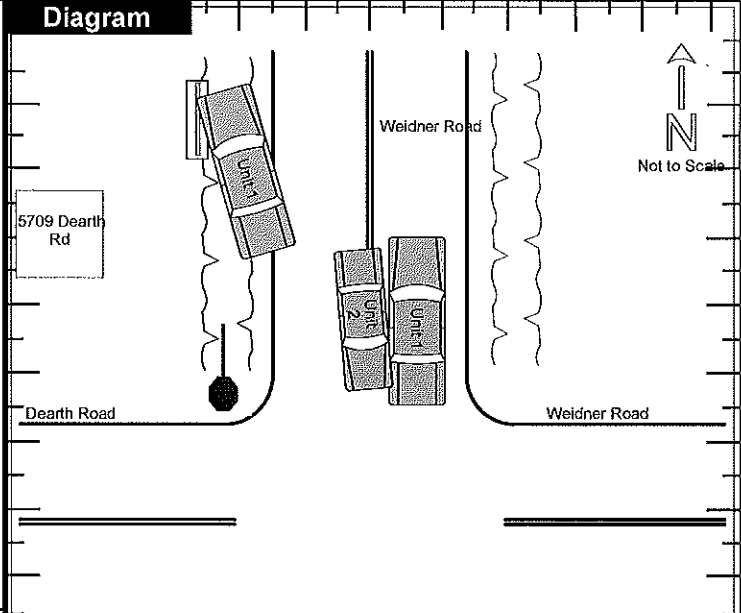

NARRATIVE:
Unit # 1 was traveling westbound on Weidner and conducting a right turn to travel northbound on Weidner Road. The driver of Unit #1 stated that the driver of Unit #2 was traveling southbound on Weidner Road and in doing so traveled left of center. Unit #2 collided with the rear driver side of the Unit #1. Unit #1 traveled off the left side of the roadway and collided with a concrete drainage ditch in the yard of 5709 Dearth. The driver of Unit #2 then fled the scene of the crash.
