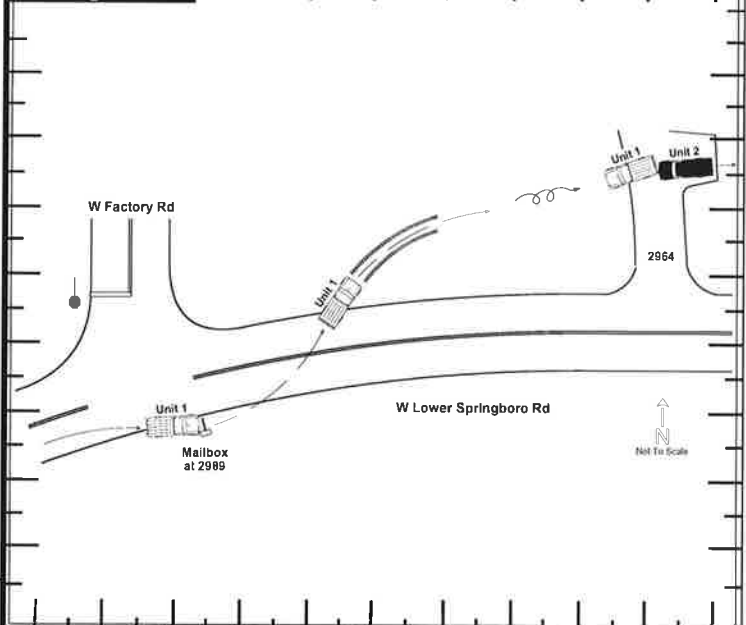
LOCATION OF CRASH IN WORK ZONE
