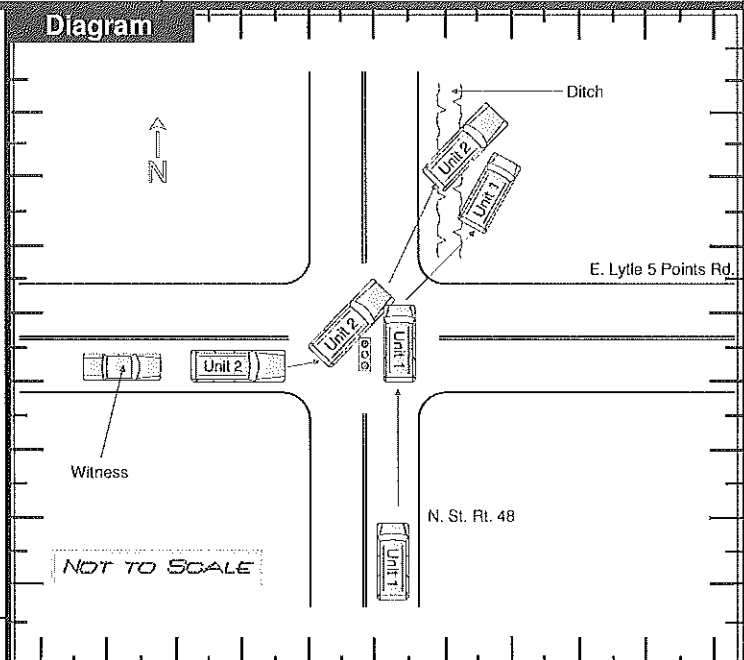

NARRATIVE
Unit 01 was traveling northbound on N. St. Rt. 48. Unit 02 had a green light and was turning left from eastbound E. Lytle 5 Points Rd. to northbound N. St. Rt. 48. A witness was behind Unit 02 but turned right onto southbound N. St. Rt. 48. Unit 01 failed to stop at the red light, striking Unit 02. Both Unit 01 and Unit 02 then exited the road right and traveled through a ditch before stopping.
