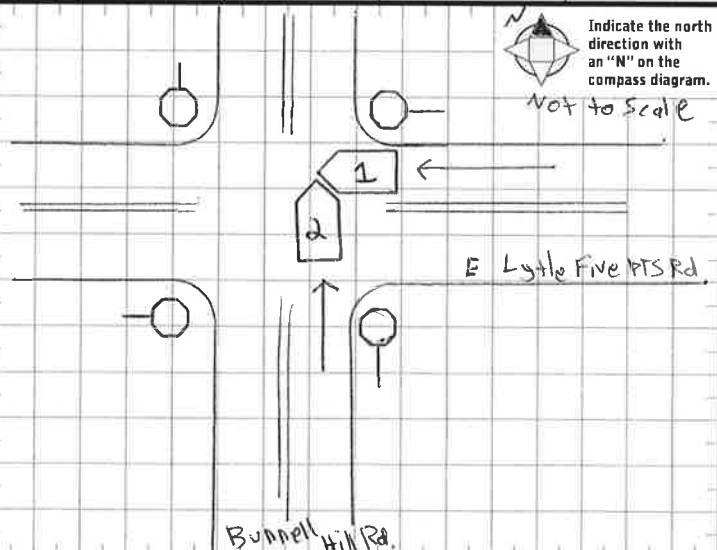

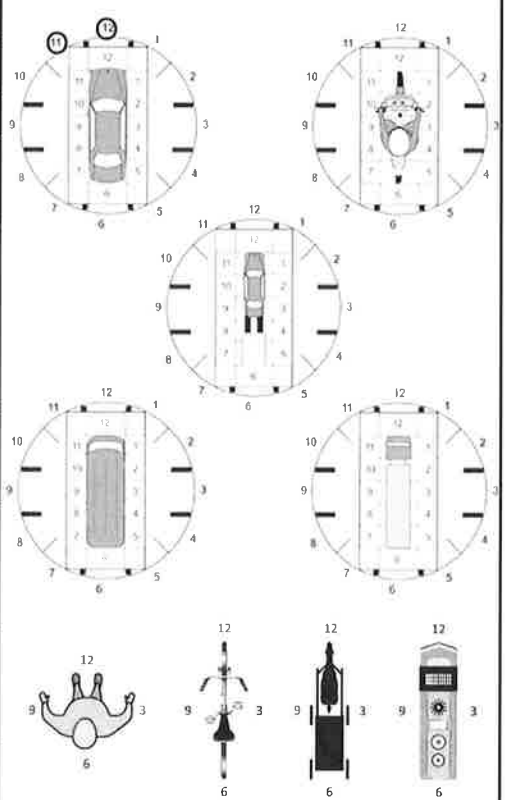

UNIT 1 INITIALLY STATED SHE WAS NOT SURE WHAT HAD OCCURRED. SHE SAID THAT SHE WAS HIT IN THE INTERSECTION. AFTER FURTHER QUESTIONING UNIT 1 SAID THAT THE CAR IN FRONT OF HER HAD WENT THROUGH THE STOP SIGN AND THEN SHE APPROACHED THE STOP SIGN. SHE SAID THAT SHE OBSERVED TRAFFIC FROM ALL DRICECTIONS PROCEED THROUGH THE INTERSECTION AND THAT SHE THEN WENT THROUGH THE INTERSECTION.
